Ordinary Resolution for Removal of Director under Section 169 In accordance with section 169 of the Companies Act, 2013, a company may, by ordinary resolution, remove a director, not being a director appointed by the Tribunal under section 242, before the expiry of the period of his office after giving him a reasonable opportunity of being heard.

### **Format of Special Notice for Removal of Director Section**

Description. Details. This Shareholders Resolution (Removing Corporate Directors) is used when the shareholders of a corporation authorize the removal of a director at a formal meeting. This resolution sets forth the date of the meeting, the presence of a quorum and that it is in the best interests of the corporation that a director be removed.

### **Draft Board Resolution for removal of Director under**

Based on this review and consideration of the removal of by the Directors, the following resolution was unanimously adopted: RESOLVED, that is removed as an Officer of the Corporation. RESOLVED FURTHER, that the Officers of this Corporation are authorized and directed to take any action necessary to effectuate the foregoing resolution.

## **BOARD OF DIRECTORS' RESOLUTION REMOVING AN OFFICER OR DIRECTOR**

With the death of a person, he immediately ceases to be the director of all the companies where he was holding the directorship. The board of directors of all such companies in their succeeding meeting take note of the demise of the director and the contribution of the director towards the growth of the company.

### **Special Notice of Resolution to Remove a Director**

For example, requiring a special resolution to remove the director (i.e. more than 75% of votes in favour of removal). To commence the process of removing a director, the company's shareholders must call for a general meeting to vote on whether or not to remove the director and pass a resolution.

In the event that the particular matter(s) with which the company is dealing can be handled by way of a directors' resolution, section 248A of the Act permits resolutions to be passed by multi-director companies without a meeting, if all the directors entitled to vote on the resolution sign a document containing a statement

that they are in favour of the resolution set out in the document.

### **Resigning or removing a company director | ASIC**

However note that the written resolution procedure cannot be used to remove a director or an auditor from office. When a shareholders' resolution is passed, the company is bound by it. All special resolutions and some ordinary resolutions must be filed at Companies House.

Members (shareholders) can remove a director by resolution (s 203D (1)). This is despite anything in the company's constitution, an agreement between the company and the director or an agreement between any or all members of the

A director can resign as a director of a company by giving written notice of your resignation to the company at its registered office; A proprietary company may, by resolution, remove a director from office and may by resolution appoint another person as a director instead; A public company may, by resolution, remove a director from office
